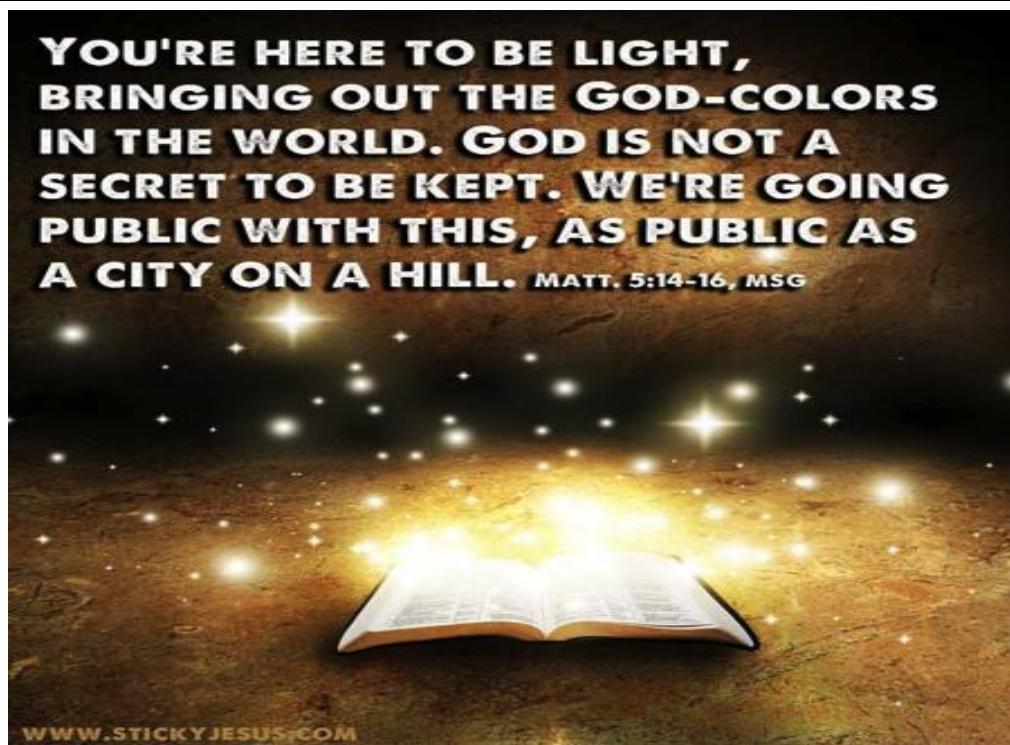

PROPOSED STANDING RULES OF PROCEDURE

2017 EaND Women of the ELCA Synodical Convention

1. **Delegate (Voting) Body** – The voting members to be seated at the convention shall include synodical board officers, the churchwide representative, and one woman from each congregational unit.
2. **Seating of Delegates** – Delegates must register before being seated in the section reserved for them. The roll of delegates may not change after 10:00 a.m. September 16, 2017. If a delegate must be absent, she shall report to the Credentials Committee Chair.
3. **Quorum** – A majority of the delegates in attendance at the convention from the units shall constitute a quorum.
4. **Privilege of the Floor** – Seat and Voice shall be granted to the Bishop of EaND Synod, representative of Church wide Women of the ELCA, SWO Board members, Chair of committees in connection with their reports.
5. **Appointment of Convention Committees** – The presiding chair, at the opening of the business meeting shall announce the appointment of the following committees: Report of the President, Credentials, Offerings, Nominating, Elections, Resolutions, and Minutes.
6. **Voting and Parliamentary Procedure** – To be eligible to vote, a delegate must be seated in the designated area. No proxy or absentee voting is permitted. Robert's Rules of Order, latest edition, shall be the governing parliamentary law of this Synodical Women's Organization, except as otherwise provided in the synodical constitution and bylaws. This convention shall follow the Women of the ELCA Policy of Electioneering.
7. **Conduct of Elections** – The nominating committee shall nominate two persons for each vacancy. Additional nominations may be made from the floor for all elections for which nominations have been made. All elections shall be by ballot. In all elections, a majority of votes cast shall elect, except in the election of delegates to the Triennial Convention.
8. **Motions/Resolutions** – Any delegate may make a motion to present a resolution from the floor. If a delegate chooses to add any item of new business, she shall: a) Write the resolution on the appropriate form; b) Submit the form to the Resolutions Committee. The Resolutions Committee shall report to the Convention its recommendation regarding the new business. A two-thirds vote of the voting body is required to add a new item of business to the agenda.
9. **Speeches** – All speeches in general discussion, unless otherwise determined by a two-thirds vote, shall be limited to two (2) minutes. No person shall speak more than twice on the same issue without the consent of the voting body and only after all others have spoken; speakers shall identify themselves by name, congregational unit, and city to be recognized by the chair.
10. **Convention Business Agenda** – The president of the synodical women's organization shall be granted the privilege of adjusting the agenda and the items of business deemed necessary.
11. **Incomplete Business** – Any business that cannot be completed by the scheduled hour of closing shall be referred to the synodical board for action at a regularly scheduled SWO business meeting.

9:30 AM Opening Worship and Communion Service led by Pastor Beth Peterson

10:45 AM Deb Stark, President of United Lutheran WELCA extended a warm welcome to all present. Karen Retzlaff, President of Synodical Women's Board announced the opening of the 29th Annual EaND Synodical Convention open. Theme: "Strangers Among Us" . Bible Verse: Matthew 25: 35-36.

Nadine Olson gave the credentials report. As of 10:05 AM Present were 24 delegates, 4 officers, total voting delegation = 28. Total present = 77.

Karen introduced the EaND Synodical Women's Board. Jessica Miller, Promoter for the Triennial Convention spoke about the Convention to be held in Minneapolis on July 13-16, 2017. Julie Garrett, EaND promoter spoke about the bus that will be going to Triennial. Stops are in Jamestown, Devils Lake and Fargo. They will need 55 people for each bus costing \$100 each. Rooms are a block away from the Convention Center. Julie has the form to sign up for the bus. Char Gumke gave greetings from the Office of the Bishop. Mitch Devillea, a Haitian Missionary spoke.

11:10 AM Joan Iverson, Churchwide Representative spoke. Joan shared her life history on her role in the church. She gave her report from Churchwide. We need to send in regular offering to the SWO Treasurer. The Churchwide went over their budget by 2%. The CWO depends on volunteer support. The Thankoffering and regular offering can be given on the online website. You can also give to the Faithful Friends and plan on giving a Legacy to CWO. We gave \$7000 less on regular offering, but our Thanksgiving offering was \$14,000 more. Joan suggested we attend the Triennial Convention from July 13-16, 2017, even if we are not delegates to see how it's run. The website is WELCATG.ORG.

11:45 AM Our guest speaker, Betty Gronneberg, is founder and Executive Director of uCodeGirl, a non-profit organization with a vision to inspire, educate, and empower young girls to choose technology careers. Betty's advocacy extends to advancing literacy in early childhood in her native country, Ethiopia. Betty has written a children's book entitled "The Alphabet Takes A Journey: Destination Ethiopia!"

The table prayer was sung and a delicious lunch was served by the ladies of United Lutheran Church

1 PM The first plenary was called to order by President Karen Retzlaff with the reciting of the Purpose Statement. Karen Retzlaff explained non-voting members may go to vendor displays or stay for the plenary. The proposed Standing Rules of Procedure on page 7 of the convention

book were reviewed. Vote by showing of hands is acceptable. The Standing Rules were adapted. A motion was made for the adoption of the agenda with changes as necessary for the purpose of this convention. Motion carried. Agenda adopted.

The Convention committees were introduced. Nancy Kainz reported we have one resolution. Whereas: The United Lutheran Church WELCA has so graciously hosted this 29th Annual Eastern North Dakota 3-B Synodical Convention, and Whereas: the goal of this group is "to reach out without fear: and Whereas: we are celebrating our theme "Stranger's Among Us" today; therefore, be it resolved that we lift up in prayers of thanks to the United Lutheran WELCA for giving his this day of nourishment for our body, soul and spirit knowing that at the center of this convention is our Lord, Jesus Christ; therefore, be it further resolved that we give a round of applause to the women of the United Lutheran Church for their hard work, love and hospitality. Karen Retzlaff moved the adoption of this resolution. Vote taken and Resolution #1 was adopted.

Karen Retzlaff went over the ELCA Policy of Electioneering on page 21 of our Convention book. Joan Iverson led us in prayer.

Nancy Kainz presented the nominations for President, Karen Retzlaff. There were no nominations from the floor. Vote taken. Nancy Kainz reported that there were no nominations for Secretary. There were no nominations from the floor. After discussion, Pam Neumiller accepted the position. Joan Iverson led us in prayer. Vote taken. We have an election for President, Karen Retzlaff, and Secretary, Pam Neumiller, each for a 2-year term.

Nancy Kainz presented the nominations for Cluster Representatives: Grafton Cluster, Crystal Anderson; Wahpeton Cluster, Kathleen "Kathy" Johnson. There were no nominations for Prairie Rose Cluster or Jamestown Cluster. After discussion, Julie Garrett accepted the position of Fargo Cluster Representative to replace Pam Neumiller. Joan Iverson led us in prayer. Vote taken. We have an election for Grafton Cluster representative, Crystal Anderson; Wahpeton Cluster representative, Kathy Johnson; Fargo Cluster representative, Julie Garrett.

Nancy Kainz presented the nominations for Triennial delegates. Mary G(Gay) Frojen, Julie Garrett, Janet Hughes, Nancy Kainz, Nadine Olson, Dil Rai, Patricia J Schutt, and Kristi Houska. Joan Iverson led us in prayer. Vote taken. We have an election for Triennial Delegates.

Nadine Olson gave the credentials report. As 12:50 PM, present were 24 delegates, 4 officers. Total voting delegation = 28. Total present were 78. The offering was \$2025.09 and the money will be dispersed as follows: 1/2 to churchwide = \$1013.04; 1/4 to EaND SWO = \$506.52; and 1/4 to Cavalier County Violence and Abuse Center = \$506.53. Nadine move the report of the Finance and Budget report on pages 12 and 13 of the Convention book be adapted. Vote taken. The report adopted as printed.

Nancy Kainz moved the adoption of the minutes on page 10 and 11 of the convention book. Vote taken and report adopted as printed. Sharon Rostad moved the adoption of the President's report on pages 8 and 9 be adopted. Vote taken and President report adopted.

There were no invitations to host the 2017 SWO Convention.

The SWO Women's Retreat for next year will be held August 19, 2017 at Maryvale in Valley City.

Karen Retzlaff presented Joan Iverson with a beautiful painting. The SWO Board presented the United Lutheran Church WELCA with a quilted wall hanging.

Joan Iverson, CWO Representative, expressed her thanks to the outgoing board members and installed the new EaNDSWO officers, board members and Triennial delegates.

We closed with the Lord's prayer.

President Karen Retzlaff adjourned the convention.

Mission Action, Growth, Community, Prison Ministry, and Young Women's Outreach

This report continues the tradition of sharing what has been happening in Eastern North Dakota as a result of WELCA activities. This past year a WELCA Ministry survey was sent to all congregational units. Of 194 active units in Eastern North Dakota, 33 surveys were returned. While this result was disappointing, I learned the following:

- Resources used (mostly GATHER magazine) 62
- Quilts made 2700
- Baby Care Kits 571
- Personal Care kits 975
- Fabric Kits 178
- Fleece Blankets 100
- Soap 85 lbs.
- School kits 228
- LWR support (financial) \$3826.45
- Churchwide/Global support \$28,808.54
- In-kind local (financial) \$19,754.00
- Synod/local (financial) \$92,781.75
- Thankofferings (services) 81 (financial) \$5285.77

Units have sponsored mission trips to various places in the world. They have helped with Global Mission projects in the Central African Republic as our companion synod faces the chaos of civil war. Units go to a variety of locations to serve meals for the homeless in shelters across our Synod. They offer clothing, bedding, and kitchen supplies for refugees who hope to resettle in North Dakota. Lutheran Social Services has provided the means for giving assistance to new Americans.

Our fifth annual Women's Retreat was held in August—with great success. These retreats provide a chance for women to “check out” of their daily lives to be renewed, refreshed, and ready to take on the challenges of life. The site at Maryvale offers a quiet, restful atmosphere for those who attend for a day.

The bassinette bedding is an on-going project for Sanford Hospital and hospitals that care for NICU infants. Julie Garrett began this project and continues to encourage women to help whenever possible. Baby quilts and children's quilts are always appreciated by emergency rooms in hospitals. Check with your local hospitals to see if there is a current need. If there is, please consider donating smaller quilts to those places.

With the increase of trafficking in our state, we became involved in helping victims of trafficking as they were located and brought to recovery programs. Our women can help in many ways. Victims of domestic abuse also need our help. Community intervention centers are always in need of personal care items, pajamas, clothing, blankets, etc. Check with your local centers for a needs list. Often women (and children) who leave an abusive situation, have nothing but the clothes on their backs as they arrive at a shelter. It is a horrific time and the comfort of a blanket or stuffed animal may make the difference in the life of a child who has seen what no child should ever see or experience!

Our prison ministry is still accepting yarn for the Jamestown Correctional Center. The inmates are still crocheting and knitting caps, sweaters, mittens, afghans, and scarves for those in need in this country and worldwide. This helps the inmates look beyond themselves to places they have never been and to provide help to the unknown recipients. They make a difference and feel better about themselves—lives are changed! Contact Chaplain Mark Haines at the Jamestown Correctional facility for more information.

As the apostle Paul once said, “Never cease in doing good!”

Report of the Editor of *CONNECTIONS*:
Newsletter of Eastern North Dakota Synodical Women's Organization
September 16, 2017

The newsletter of the Eastern North Dakota Synodical Women's Organization is currently in its 20th year of publication with Karen Retzlaff as editor. A variety of previous newsletters were composed by others intermittently for various purposes. At one time, only the SWO Board received regular updates of events in the Synod. This was expanded to newsletters for church units and later subscriptions for individuals were added. The publication is usually 4 pages long with the larger edition following the Synodical convention. The larger edition includes photos and information about the convention held in September every year.

The editor uses Microsoft Publisher to prepare the issue prior to printing. The copy is converted to PDF and sent to Ness Press of Fordville, ND, for printing and distribution. The editor maintains the mailing list and continues to update it regularly. Subscriptions are sent to the editor and money transferred to the Treasurer. There is often a time lag, since the money is often held until a SWO Board meeting when it is turned over to the treasurer. (That may be the reason for checks not clearing on a monthly basis. Do not worry—it will be deposited!) Your subscription label includes a “code” to let you know when your subscription expires. It looks like this: “Jane Lutheran JL/18”; this means “Your Name” “month/ year of expiration of the subscription.”

Speaking of subscriptions, it is becoming more costly for the editor to retrieve and resend newsletters. This happens when churches and subscribers fail to update addresses when churches close or go from PO boxes to 911 addresses (and vice versa) OR move to another location. The mail is not forwarded, but rather is returned to the editor who has to pay postage due (\$0.49) and resend (\$0.49 paid again) therefore adding \$.98 to the original cost of mailing the newsletter. Please take a few seconds to drop an email (retzlaff@polarcomm.com) or snail mail (address below) to continue your subscriptions.

The editor is often looking for news from Congregational units, or WELCAs, to include in the issues. A possibility could be a story about programs held by the WELCAs. So often program chairmen are at a loss when Cluster Gatherings are planned. If we share information, many more can benefit from successful programs held in Eastern North Dakota's congregational units.

Today's Dream, Tomorrow's Reality
Racial Justice Team Report
2017

“Today’s Dream, Tomorrow’s Reality” (TD-TR) is the title used for the anti-racism program of the Women of the ELCA. With the 2011-2014 Triennial Convention action, the focus has changed to Racial Justice Advocacy. The goals are still the same, but the title has changed. With the retirement of Inez Torres-Davis this past spring, the Women of the ELCA staff is being reassigned to continue this important program.

The program materials have been revised to reflect some of the changes from the first programs of the group with a focus on advocacy for justice for all people. While program materials have been used with great effectiveness, there is always room for improvement.

The TD-TR materials have been rewritten and updated with the assistance of a team of women from the network. Karen Retzlaff was one of those team members. The result of the process is a number of programs on the WELCA website that are downloadable for use.

The in-depth trainings give participants the opportunity to study God’s Word to discern His Will in the work of racial justice. Karen Retzlaff and Darla Thiele of the Racial Justice team members from Eastern North Dakota, have taken part in these trainings and are available to speak to groups about this important program.

The Ninth Triennial Convention delegates passed a resolution to advocate for children in crisis who are coming to the United States by the hundreds for safety from the violence in their home countries. This is a justice issue for the children who need to escape the murder and violence in Central America. Members of TD-TR formulated and introduced the resolution to the convention delegates. It was passed by a vote of 318 ayes to 30 nays for a total of 348 votes cast.

The current unrest in the United States has brought racial tension to the forefront of issues. With the violence occurring in many areas, it is time to talk about race and how to combat the hatred expressed by numerous groups. It begins by immersing ourselves in God’s Word to be His voice in bringing justice.

Please consider prayerfully, hosting a program in your congregational unit or your congregation to learn more about Racial Justice.

Prairie Rose Cluster Gathering Report
Grace Lutheran Church Grace City, North Dakota
9:30am-3:00 pm April 1, 2017

The Prairie Rose Cluster met at Grace Lutheran Church in Grace City on Saturday, April 1, 2017 with 44 participants. They were welcomed with coffee and fellowship time during registration from 9:30-10:00 am.

Laura Kulsrud welcomed everyone to Grace Lutheran and shared a bit of the history of the church. The original building burned in 1981 and was rebuilt in 1982. In 1992 the congregation became part of the Tri-County Ministry.

Pastor Sherri Fredrickson opened the time of devotion with a prayer and shared information about Amparo, a program also referred to as “Opening Borders”. She recalled a trip to Juarez, Mexico, where she experienced the life of those attempting to cross into the United States. She visited those imprisoned near the border and shared her stories of God’s presence among those prisoners. She spoke of injustices faced by those in Mexico, where jobs are hard to find, drug lords are powerful, and children have no future. She challenged the women to work for justice.

Because two of the speakers were unable to be part of the day’s program, Laura Kulsrud, the third speaker, was able to tell her story of “A Family’s Journey with PKAN” in its entirety. Pantothenate kinase-associated neurodegeneration is a genetic, neurological disorder which is quite rare. Laura explained that her oldest son was diagnosed in 2011 at the age of 11 and that her second son has also been diagnosed with the disease which causes an accumulation of iron deposits in the brain resulting in physical degeneration. Most PKAN patients do not survive past their twenties.

She told of the efforts to have her children put into a variety of drug studies to give them a chance at life. Since PKASN is very rare, there are few drug companies working on medications to slow or halt the progression of the disorder. She related that her faith has been a source of strength through this journey.

A noon meal was provided by Grace Lutheran WELCA. In-kind offering was items for Sacred Journey Lodge in Woodworth, ND.

1. Whereas EaND Synodical Women of the ELCA (EaND SWO) currently has eight clusters/conferences;

5. Whereas it can cost each EaND SWO cluster/conference approximately \$400; and
6. Whereas it also costs each EaND SWO cluster/conference mileage at the rate of .50 per mile for board representation; now therefore, be it

Resolved that we

1. recognize that EaND Synodical Women of the ELCA (EaND SWO) has eight cluster/conferences;
2. urges that each EaND SWO cluster/conference representative could come together in groups of four (Grand Forks, Grafton, Devils Lake, Prairie Rose) & (Fargo, Jamestown, Mayville, Wahpeton);
3. urges that two groups of four clusters join together each spring (Grand Forks, Grafton, Devils Lake, Prairie Rose) & (Fargo, Jamestown, Mayville, Wahpeton);
4. recognizes that attendance may increase per event
5. recognizes that what was approximately \$1600 to host would now cap off at approximately \$600 to \$800

and recognizes that mileage for EaND SWO members attending would be lessened with only two events to attend; and

6. urges the consideration to restructure the spring EaND SWO gatherings (Grand Forks, Grafton, Devils Lake, Prairie Rose) & (Fargo, Jamestown, Mayville, Wahpeton) to this format.
